● Police Chief Filipi came before the Board to advise that several political signs have been stolen on multiple occasions. ●Based on new information, the Board has decided to seek an Eversource Battery Backup Grant through an award given to CENH that would provide 50% of the cost of Battery Backups for all Resiliency buildings including the Town Hall, Library, Town Office and Safety Building. This grant has additional funding of 30% tax credit to the Town if awarded.
