Brenna called the October 22, 2025 meeting of the Nelson Select Board to order at 3:00 PM.

• Mike made a motion to approve the minutes for October 15, 2025 as recorded.

Mike made a motion to approve the manifest for October 22, 2025 as presented.

• Upon reviewing a request for 2026 Budget funding, Mike made a motion to approve \$1,500 to be added to the Social Services warrant article for Home Healthcare, Hospice, & Community Services, noting that it is up \$950 over last year.

Brenna seconded.

The motion carried 2-0.

- The Board agreed to hold off on further discussion of Spaeth Road abutter letters until Don returns.
- Notice has been posted for the Public Hearing to be held on November 5, 2025 for public comment regarding the Select Board accepting the gift of the Munsonville Cemetery property and all funds offered with the land for continued maintenance.
- Mike made a motion to approve the 2026 -2027 Primex Contributions for Workers Comp and Property/Liability, noting an increase of \$752 for Property/Liability and an increase of \$2,956 for Workers Comp. (Totals \$26,771 for Prop/Liab. & \$8,598 for W. Comp) Brenna seconded.

The motion carried 2-0.

- Mare- Anne Jarvela, Chair for the Agricultural Commission, came before the Board with a concern over a lack of membership. Currently there are only two members and therefore not enough for a quorum to hold a meeting. While past activities such as the seed library, small garden behind the library, and speakers at Old Home Day, and canning classes have been well received, there doesn't seem to be enough sustainable interest to maintain an active commission. Brenna offered to speak to S. Wilson to see if she might like to join. All agreed that a notice in the Black Fly may generate additional interest. Jarvela agreed to write up something for submission to G. Peery.
- ●The Board reconsidered a request from Nelson in Common to hold a contra dance in February 2026 and to be granted use of the Town Hall rent free. (The public would not be charged admission) Following a brief

discussion, Mike made a motion to hold the Board's previous decision to charge the resident rate of \$95.00 and suggested that G. Peery rent the Town Hall in in his own name and use his homeowner's insurance to cover the liability rider that is required.

• Following a review of the 2026-2027 HealthTrust notice, reporting a 10.7 percent increase, Mike made a motion to approve the new amounts for the 2026 budget.
