At 3:05 PM David Upton opened the February 13, 2019 meeting of the Nelson Select Board.

● Phil Hamilton came before the Board to present a request from property owners located at 44 West Shore Road. This property is currently undergoing construction of a new dwelling to replace a pre-existing home. The property owner was granted permission to bury their new septic line under West Shore Road. They would now like to bury their electric & phone service lines in the same path under West Shore Road. Mr. Hamilton presented a case for burying the lines but it was noted that the Road Agent has concerns over including those service lines in this project.

David suggested that Mike Tarr develop a set of specs that he would be comfortable with including depth, and containment for the lines in addition to requiring a "Hold Harmless" agreement to protect the Town from liability. All agreed to continue more detailed discussion with the Road Agent before finalizing a vote.
