At 10:00 AM David Upton opened the March 10, 2021 meeting of the Nelson Select Board.

- David reported on the solar production of the newest solar array at the Highway barn. (Nearly 4000 Kwh)
- David made a motion to approve the Public and Non-Public minutes for March 3, 2021.  
Maury seconded.  
The motion carried 3-0.
- David made a motion to approve the manifest for March 10, 2021.  
Maury seconded.  
The motion carried 3-0.
- David made a motion to approve a request from L. Derby for a Concert on the Common to be performed by Monadnock Music on August 7, 2021 with a rain date of August 8, 2021. They will provide a tent for the musicians and guests are asked to bring their own seating.

- Following a review of plans for privacy fencing on West Shore Road, David made a motion to require that placement meet the street line requirement of Nelson's zoning regulations. (20 ft from center of the road) and that it does not cause obstructed view for drivers along the road.

- Following a review of building plans submitted by D. Robinson, David made a motion to deny the permit because the building addition would not meet the road setback requirement, and further to refer the applicant to the ZBA to seek a variance.

- David made a motion to approve a request from Planning Board Chair, M. Cornog to seek legal counsel on a matter soon to be addressed by that Board.

- David made a motion to approve two Purchase Requests from the Highway Department. 1. Loader edges at \$1041.00 and Grader blade at \$2168.00.
