Brenna called the March 27, 2024 meeting of the Nelson Select Board to order at 3:00 PM.

- Police Chief J. Filipi came before the Board with an update on follow-up of a complaint of Junk Cars being brought to a property on Nelson Road as well as an update of reported garbage dumping in the area of Blueberry Lane. Chief Filipi met with both property owners to discuss options for improving their situations and not cause further harm to their neighbor's view. After reviewing the document, Filipi accepted the position and signed the contract as presented.

• Mike made a motion to approve the manifest for March 27, 2024 as presented. Brenna seconded.

•Mike made a motion to approve a letter to the Trustees of Trust Funds requesting the withdrawal of \$20,000 from the Town Buildings Capital Reserve Fund in accordance with approval of article #12 at the 2024 Town meeting. (Roof repair & shingling of Town Hall prior to Solar installation) Brenna seconded.

The motion carried 3-0.

- Sandy Mackenzie came before the Board to discuss the possibility of changing the design and material for the Welcome signs approved at the 2024 Town meeting. Brenna agreed to discuss the suggested changes with the sign company. Sandy offered to donate the sign's mounting structure to the Town at no cost. The sign and installation onto the structure would be covered in accordance with the approval of article #15 at the 2024 Town meeting. The final design decision is pending further discussion with the sign maker.
