● Police Chief Joseph Filipi came before the Board for an update of the Police Department for the first quarter of the fiscal year.

- Patrols have begun - Limited in some areas due to mud season
- Calls are being dispatched as reported
- 2014 cruiser was taken in for routine service as well as a recall
- The department acquired a used safety cage from a neighboring town at no cost
- Installation of the cage is being scheduled for the 2014 cruiser
- The Police office has been freshened and organized resulting in 2 desks that are not needed
- The desks will be offered to other departments
- Research has begun for the purchase of a new cruiser next year to replace the 2004 Ford
- With the retirement of the Town prosecutor, a contract is being developed with a new attorney
