

**Town of Nelson**  
**Selectmen's Meeting 3:00 PM**

April 10, 2019

Executive Board Attending: David Upton, Gary Robinson, Edie Drinkwater, Admin. Assist.

Others attending: J. Lennon

At 3:00 PM David Upton opened the April 10, 2019 meeting of the Nelson Select Board.

● J. Lennon came before the Board to request abatement to a taxpayer that was overcharged for 2 years of vehicle registrations. Lennon reported that the taxpayer just brought the mistake to her attention following this year's registration.

The Board agreed to review the matter further before making a judgement to abate.

● Lennon further informed the Board of the annual "Lien and Deed" list due to unpaid property taxes. Lennon informed the Board that one property owner remains on the list due to unpaid interest. Lennon asked the Board to consider abatement for that property owner. The Board agreed that an abatement request should come from the property owner.

Lennon went on to review other properties on the list.

The Board took no action on any of the "Lien and Deed" properties at this time.

● The Board agreed that Lennon should continue with collection efforts at this time.

● David made a motion to approve the minutes for March 27, 2019.

Gary seconded.

The motion carried 2-0. Maury was absent

● Gary made a motion to approve the manifests for April 3 and April 10, 2019 as presented.

David seconded.

● The Board reviewed the final MS-232-R from DRA and reported an exact match to the figures submitted by the Town.

● Gary made a motion to approve a letter to the Road Agent regarding the "Fire Doors" in the Highway garage.

David seconded.

The motion carried 2-0.

● David made a motion to approve a Purchase Request from the Fire Department for a new member to begin EMR training.

Gary seconded.

● David made a motion to approve a letter to J. Walter regarding personnel matters.

● David made a motion that the Nelson Board of Selectmen proclaim April 2019 “Child Abuse Prevention Month”.

● David made a motion to appoint Kathy Schillemat to a 3 year term to the Conservation Commission. The appointment will expire March of 2022.

● David made a motion to approve a letter to the Trustees of Trust Funds for a withdrawal of funds from the Milfoil Expendable Trust Fund to support the Lake Host Program at Nubanusit Lake as recommended by the Nelson Conservation Commission.

● David made a motion to appoint the following members to the Agricultural Commission:

Sam Romano – 3 year term to expire March of 2022

Barbara Fraser – 2 year term to expire March of 2021 (Completing term held by B. Voymas)

and

Mare-Anne Jarvela – Alternate for 3 year term to expire March of 2022

Gary seconded.

The motion carried 2-0.

● David made a motion to approve the continuation of Roberts & Green, PLLC as the Town’s auditing firm and to approve their contract thru 2020.

Gary seconded.

The motion carried 2-0.

● Following a discussion of parking issues in the village, it was agreed that language will be developed with the Police department to be printed on “Warning” tickets that will inform vehicle owners of the rules for extended parking as well as the restricted winter parking regulations.

● Following the resignation of Rick Lothrop as Forest Fire Warden, the State is awaiting a recommendation by the Selectmen for this State appointment.

David made a motion to recommend Richard Pratt for appointment by the State of New Hampshire as Forest Fire Warden for Nelson.

Gary seconded.

The motion carried 2-0.

● The Board reviewed a letter of suggestion regarding a traffic matter on Granite Lake Road.

The Letter will be forwarded to “Share the Roads Committee”.

● David made a motion to approve the following allocation of annual stipends for the Select Board:

M. Collins - \$2,000
