Brenna called the April 2, 2024 meeting of the Nelson Select Board to order at 1:00 PM.

● Police Chief J. Filipi came before the Board with a brief update regarding the complaint of Junk Cars being brought to a property on Nelson Road. At this time Chief Filipi expects agreeable cooperation to continue as an appropriate screening solution is determined.

As J. Filipi leaves his current Full-time position as a Firefighter/AEMT in Lebanon his current custom gear was offered to Filipi at no cost. This gear has 5 years remaining before expiration of use and can be used in Nelson as Filipi joins the Nelson Fire & Rescue Department. Lebanon had also ordered a new set of uniform gear for Filipi and has offered to sell this new gear to Nelson. The cost would run approximately \$5,000 and would substantially deplete the current Fire Department Uniforms and gear budget. This matter will be considered during further discussions that will include the Nelson Fire Chief.

● Brenna made a motion to approve the minutes for the March 27, 2024 Selectmen's meeting as recorded.

● The Board read a Thank You letter from Southwestern Community Services for the Town's support of their social services program.

● Brenna reviewed her meeting with the sign maker and was convinced, after viewing samples of his work, that the original metal Welcome signs will give many more years of service without the wearing and fading of the molded or carved signs. The Board is awaiting an additional estimate for the sign using raised lettering. The size of the sign is recommended by the designer to remain as originally quoted (37" wide X 42" high). This would afford the best readability when driving past the signs. Consideration of the options will continue.

● The manner of disposal of the Fire Department's older fire hose has been brought to the Board's attention. The Fire Chief will be asked to meet with the Board to discuss the matter further.
