Richard Pratt, Fire Warden, has agreed that requests for Burn Permits can be submitted to the town office for logging in and then will be forwarded to the Fire Warden. Instruction will be put on the Fire Department page of the Town website outlining the information needed from applicants.
- Following a brief discussion, Maury made a motion to approve the limited reopening of the Town Office on May 10, 2021 with social distancing, mask wearing, and hand sanitizing protocols as developed and approved by the Town Clerk and Administrative Assistant.
