Selectmen's Meeting 1:00 PM

June 2, 2021

Executive Board Attending: David Upton, Maury Collins, Gary Robinson, Edie Drinkwater, Admin. Assist.

At 1:00 PM David Upton opened the June 2, 2021 meeting of the Nelson Select Board.

- David made a motion to approve the minutes for May 26, 2021 as recorded.

Maury seconded.

The motion carried 2-0. (Gary was absent from the meeting)

- David made a motion to approve the Manifest for June 2, 2021 as presented.

Gary seconded.

The motion carried 3-0.

- David made a motion to approve a Purchase Request from the Police Department for the purchase of a new printer. (\$771)

Maury seconded.

The motion carried 3-0.

- David made a motion to accept the terms of the Emergency Management Performance grant as presented in the amount of \$3,500 to update Nelson's Local Emergency Operations Plan (LEOP). Further to acknowledge that the total cost of the project will be \$3,500 in grant funds and, in addition, the town will be responsible for an in-kind match valued at \$3,500 in participation by town officials.

Maury seconded.

The motion carried 3-0.

- Following a brief discussion, it was agreed that Gary will attend the Cemetery Board meeting on June 15, 2021 at which time a contracted cemetery designer will evaluate the new cemetery location in preparation for a design proposal.

- A previous grant opportunity from SWRPC to inventory and assess all Town bridges and culverts was postponed in 2019-2020. This program has now become available but there would now be a cost to the Town. The Road Agent reported that the State already maintains a bridge inventory and performs regular inspections and that he has an inventory of all culverts.

Based on that information, Maury made a motion not to contract with SWRPC for their inventory/assessment project.

Gary seconded.

The motion carried 3-0.
