At 1:00 PM David Upton opened the June 9, 2021 meeting of the Nelson Select Board.

● David made a motion to approve the Public and Non-Public minutes for June 2, 2021 as recorded.
Gary seconded.
The motion carried 3-0.

● David made a motion to approve the Manifest for June 9, 2021 as presented.
Maury seconded.
The motion carried 3-0.

● David made a motion to approve a letter for T. Daigle informing that the Town of Nelson does not have an occupancy permit requirement to move into her new mobile home.

David seconded.

● Eversource has requested permission to cut a large number of trees along Log Cabin Road. Following a brief discussion, the request was tabled until closer checking of the trees and follow-up with other landowners along the road. Maury agreed to meet with Mike Tarr for further review and discussion with abutters.
