

# Town of Nelson Selectmen's Meeting

August 9, 2017

Executive Board Attending: David Upton, Gary Robinson, Edie Drinkwater, Admin. Assist.

Others attending: Mary Cornog, Dennis and Mary Dellagrecia, Wayne Kassotis

At 3:00 PM David Upton opened the August 9, 2017 meeting of the Nelson Select Board.

● Mary Cornog came before the Board to discuss concerns over road safety for all who share the Nelson roadways. She noted that walking, running, and biking in Nelson attracts people to the area. Many of the rural roads have blind curves, crowns in the road, dogs etc. She spoke of a national movement for road safety which includes proposals for traffic calming and crosswalks. Mary suggested that a crosswalk be considered on the Nelson Road from the Library area to the Church. Officer Wayne Kassotis noted that the State does not place crosswalks in areas that have no sidewalks. Mary requested consideration by the Board to work with Southwest Region Planning Commission on a road safety study and she offered to head up a committee.

Dave and Gary agreed to allow Mary to contact SWRPC and to begin organizing a group for appointment by the Select Board.

Dennis Dellagrecia reviewed his observations (as a resident on Nubanusit Road) of the variety of dangers including sightline problems in several areas. He noted that previous traffic studies did not reveal excessive speed on the roads. All agreed that those who use the roads for any reason need to do so in a safe manner with understanding and consideration of all other traffic varieties that they could encounter at any time. (Walkers, runners, bikers, vehicles, or construction trucks and equipment)
