The state via DES will do the initial evaluation and make the remediation plan and hire and supervise and pay for the remediation for the first year. There is grant funding that is available we can apply for after that. Local fundraising will be needed. Granite Lake has a contingency fund to help pay for remediation. The town Milfoil fund can be used, but only if it is a milfoil infestation.

Trails Committee thoughts on Monadnock view from Partridge Woods. The committee is clear that the work to clear a view from the top of Osgood Hill is both difficult and dangerous and would likely involve more trees than Al has proposed. The committee is not in favor of that plan and is exploring options to maintain some view on the clear cut.
