

## SELECTMEN MEETING


January 12, 2011

Present: Michael Blaudschun, Chair; Margaret Schillemat and Warren Hammack, Selectemen.



- 1) Mike opened the selectmen's meeting at 7:00pm, seconded by Margaret, Motion carried unanimously.
- 2) All paperwork was signed, read and acted upon by the selectmen.
- 3) Bill from Computer Solutions and the selectmen talked about computer issues and the state of the server and at least one computer in the offices.
- 4) Mike called for an Executive session at 7:35; seconded by Margaret. The board adjourned to the kitchen area with Mr. Bradshaw.
- 5) The executive session adjourned at 8:20pm by Mike, seconded by Warren. Motion carried.
- 6) The selectmen came back to the selectmen meeting at 8:25pm.
- 7) John and Anne Cucchi came with Dennis Dellagrecca to speak with the Selectmen about several topics of concern. John and Anne wanted to talk about the cell tower proposed to go over on Granite Lake. John is trying to get the NH Preservation Alliance involved in the tower location. He feels that it will take away from the Lakes beauty. They are in the process of beginning the registration as a Historical Area. John also, wants to start a Historical Committee of no more than 7 members. John says Jim Wilder is on the Granite Lake Association and is working with them to do something about the tower proposed to go on the end of Granite Lake.
- 8) John also came to speak about his property on Map 9 Lot 58 the Mill Site. He would like his attorney and the town's attorney to work on what the ZBA based their decision on for the Mill Site not being allowed to have a building built on it. The ZBA now has two new members on it and he wonders what if any changes there would be at this time. John and Anne are thinking of reapplying to the ZBA on the Mill Site again. They would like to build on this site if possible. They will be coming to the selectmen's meeting on the 26<sup>th</sup> of January at 7:30pm.
- 9) The selectmen talked about Mr. Kenneth Jeffery and his service to the town as a selectman from 1976 to 1983. Mr. Jeffery has just passed and condolences to his family from the town Selectmen and staff.
- 10) Mike called for an executive session with the Police Chief, Richard Pratt, Jr. Seconded by Warren and passed. Time was 10:05pm.
- 11) The Executive session was adjourned at 10:40pm by Mike and seconded by Margaret. Motion carried unanimously.
- 12) Mike adjourned the Selectmen's meeting at 10:45pm, seconded by Warren. Passed unanimously.
