

SELECTMEN MEETING

JULY 28, 2010

PRESENT: MARGARET SCHILLEMAT & WARREN HANNACK, Selectmen; MICHAEL BLAUDSCHUN, CHAIR WAS ABSENT.

OTHERS ATTENDING; Michael Tarr, Road Agent; Dawn Amer, Treasurer; Susan Kingsbury, Dwayne & Jeffery Schillemat, Mike Tarr & Dennis Dellagreca.

- 1) All paperwork was signed and read by the selectmen.
- 2) Selectmen read a E-Mail from Peter Harrison on Nubanusit Road. Peter was concerned that there was dirt piled on the road making it so that it was not passable. Mike Tarr said he had put some dirt up on the road so that Dennis Dellagreca could fill in the large holes and make the road better for travel and to keep vehicles from driving through the holes to splash mud all over. Mike said that he would check into the situation and see if Dennis had done the work with the sand piles.
- 3) Selectmen will send correspondence to Peter with any information they receive from Mike or Dennis.
- 4) Selectmen received information on the oil contract that Mr. Tim Ruehr, SAU 29; was working on with Jackson Energy, LLC. The selectmen looked at the contract that had a expiration date of 7/28/10. The selectmen decided to wait a few more days, no decision was made at this time.
- 5) Dawn Amer, Treasurer updated the selectmen on the Bank accounts for the town and that they were all reconciled. The town has signed up for on line banking which makes everything faster and easier. The last payment has been made on the Safety Building Loan, Hooray!!!.
- 6) Susan Kingsbury came to ask if she could change her boathouse into a studio for writing and painting. She will not be changing the footprint but will be adding insulation, propane heat, electrical etc. The selectmen had her fill out a permit for our information only.
- 7) Duane and Jeffrey Schillemat came to ask the selectmen if Jeffery could undertake for his Eagle Scout project a wooden kiosk , with glass doors to hold notices for the protection of the water fowl, warning signs for E-Coli and any other signs that should be posted for DES etc. The structure would be painted white. Pressure treated posts would be set in cement and would be on Town property. Jeffrey will be talking to the abutters of the land to let them know what is going on and to keep them informed. The selectmen approved the project and Jeffrey will also keep the selectmen informed of his progress and any problems that might arise.
- 8) Duane Schillemat asked about a ½ acre of land Map9 Lot 60 owned by the town. He would be interested in purchasing the small lot as it would give him access to his property Map 9 Lot 11 from Route 9. The selectmen will look into this and let Duane know about the piece of land he is interested in purchasing.
- 9) Mike Tarr came back to the selectmen meeting with Dennis Dellagreca to inform them that Dennis had taken care of the dirt on Nubanusit road, it has already been smoothed over the holes and is no longer in the road. Mike informed the selectmen that the road is in good shape now.
- 10) Margaret closed the selectmen meeting at 11:18pm. It was seconded by Warren and the motion passed.
