

SELECTMEN MEETING

MARCH 17, 2010

Present: Michael Blaudschun, Chair; Margaret Schillemat & Warren Hammack, Selectmen.

Other Attendees: Owen Iselin and Richard Pratt, Police Chief.

1) Michael Blaudschun opened the Selectmen's meeting at 7:05pm, seconded by Margaret Schillemat.

- All paperwork was read and signed by the selectmen.
- Motion to accept Carol Raynor as clerk of the Planning and Zoning Boards. Motion passed unanimously.
- Motion to elect Mike Blaudschun as Chair of the Select Board for the ensuing year. Motion passed unanimously.
- The Geddes Land will stay posted at this time and will not be used for hiking or other recreational activities because of insurance purposes.
- The Selectmen discussed the Vision 20-10 Committee possibilities and came up with four names. Warren Hammack, our new selectman, was interested in overseeing the project. Other names mentioned were Jack Bradshaw, Bud French and Tom Buttrick.

2) The selectmen went over the paperwork for the Geddes property to see what is feasible to do and not do with it. They will be discussing all aspects of Current Use, Conservation Easements, and any other considerations that may be applied to the property. Also, more review of the Deed is necessary. After all the changes go to the town attorney there will be a meeting before the town for further clarification. Whatever is done for this property will be done in perpetuity.

3) Mr. Owen Iselin applied for the Building sexton position. He has his own lawn equipment, including a lawn mower, The position consists of mowing of lawns, shoveling of walks in the winter, some landscaping duties, small building repairs, minor repairs and adjustments to heating and ventilating systems, makes minor plumbing and electrical repairs and replaces light bulbs etc. This will also include the Munsonville cemetery for grass cutting, brush cutting and maintenance of other work in the cemetery. Owen will be back next week to talk to the selectmen again.

4) Mike Blaudschun called for an executive session for RSA 91-A: 3 II (A + c) personnel, at 7:45pm.

Executive session adjourned at 8:00pm. by Mike Blaudschun, seconded by Margaret Schillemat. Motion carried.

5) Joan to do a letter to the Forney's for a conference call with the selectmen on March 31, 2010 or an appointment with the selectmen if they are in town. This concerns some cleanup of property.

6) At 8:40pm Police Chief called for an executive session for RSA 01-A: II (a), Police Issue.

Executive session adjourned at 9:10pm by Mike Blaudschun, Chair. Seconded by Margaret Schillemat. Motion carried.


7) Return to selectmen meeting at 9:13pm.


