

## SELECTMEN MEETING

October 20, 2010


Present: Michael Blaudschun, Chair; Margaret Schillemat & Warren Hammack, Selectmen

Others Present: David Voymas, Planning Board Chair; Bruce McSheehey, library; Barry Tolman, Russ Thomas, Sandy MacKenzie, Troy Tucker, Site Inspector and Richard Pratt Jr. Police Chief.

- 1) All paperwork was read and signed by the selectmen.
- 2) Mr. & Mrs. Wichland are requesting that the selectmen look at their land by deeds and see if a property owned by the town is their property. Cross country's David Marazoff will look into the deeds and see what discrepancies if any are there.
- 3) Computer Solutions has fixed the Police computers and set up the DSL for them.
- 4) Bruce Mcsheehey came before the selectmen to ask if the 40 or more chairs that are down in the library basement, could be removed. The chairs belong to the Town and most of them are broken. The selectmen and Bruce decided that Bruce will dispose of some of the chairs. Secondly, Bruce McSheehey asked that one of the generators be brought up and stored under the library for electrical outages. The selectmen asked that the library be wired by an electrician for a generator because gas generators cannot be stored in an enclosed basement or room.
- 5) Mr. Dave Voymas, P/B Chair and part of the steering committee for the Agricultural Commission for the Town of Nelson, brought before the selectmen a new advocate group to develop a agricultural Commission. They will place a warrant article in the Town Report this year for this Commission. They will have to place a second article if they are requesting any dollar amount.
- 6) Barry Tolman, Russ Thomas and Sandy MacKenzie came to the selectmen to see if they could make a formal request for a committee with a selectman on this committee. The selectmen informed the group that they had received a letter from the Harrisville selectmen for all of the selectmen to get together and talk about just such a concept. The selectmen will let everyone know when a meeting is set up where and when.
- 7) Troy Tucker, Site Review Officer, Checked on Mr. Eachus and his building permit. The selectmen have not signed his building permit as we have not heard anything from the DES about his septic construction. We need a DES permission slip before he can continue.
- 8) Rick Popovich, ZBA Chair, will come to the selectmen's meeting after his next ZBA meeting and let the selectmen know of their decision.
- 9) Richard Pratt, Police Chief will have Brian Lord let in the DSL people to set up the police computer.


- 10) Dave Marazoff will be in next week for the selectmen's meeting to discuss some Cross Country business with the selectmen.
